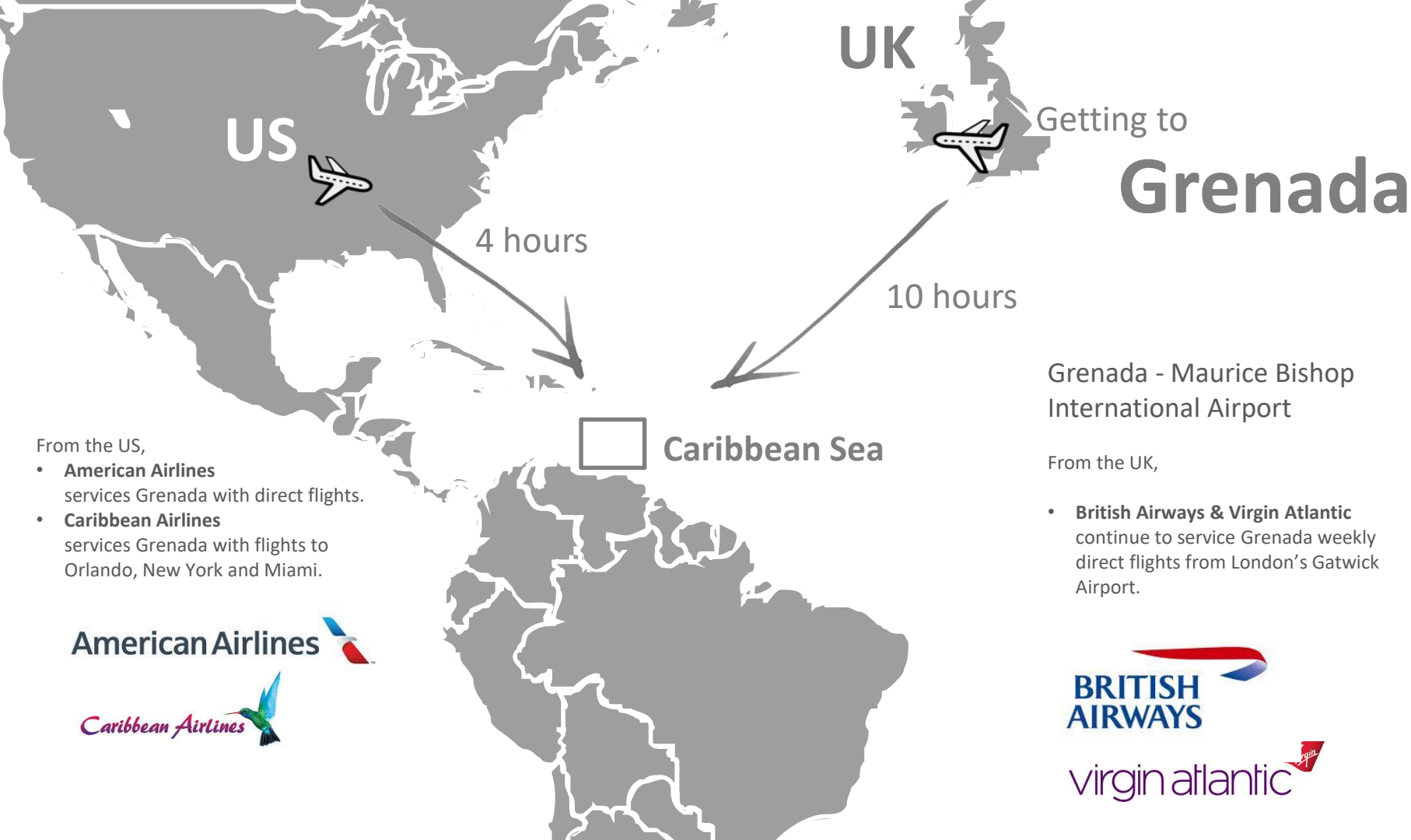
Where is

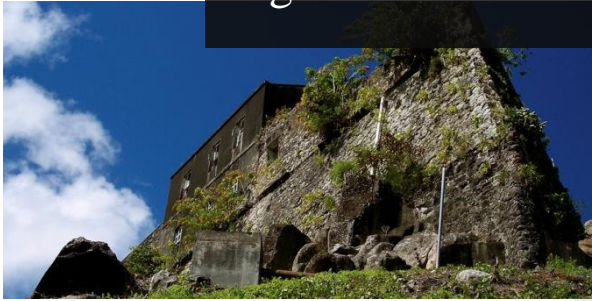
Capital of Grenada St. George's

Grenada was formally ceded to Britain by the Treaty of Paris in 1763. Independence was granted in 1974



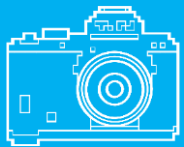
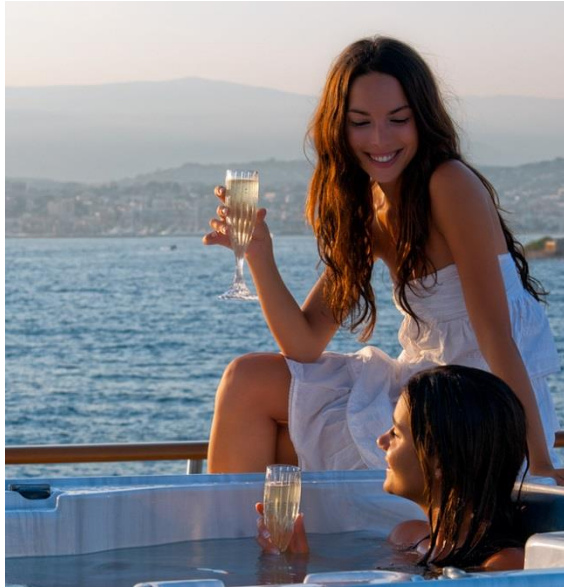
Grand Anse Beach
